Andrew Cuomo declared in his State of the State address last week that *New York is "No. 1 in spending but 34 in terms of results" when it comes to education.* But according to a new analysis released Tuesday by an established education watchdog, **New York is actually doing much, much better than that.**”

Education Week, in the annual "**Quality Counts**" guide, ranked New York State No. 2 in the nation in a comprehensive analysis of policy and performance with an overall grade of **B**. Maryland ranked first, with a grade of B+, and Massachusetts came in third with a B.

New contracts equal savings for Tully schools

The Tully school district is starting to see savings from its recently approved teachers' and clerical workers' contracts.

Tully school teachers ratified a two-year contract, approved by the school board in November, that average raises of 2.3 percent the first year and 2.5 percent the second year. The contract is for 2010-11 and 2011-12. In the last contract, Tully teachers negotiated a 3.8 percent raise, schools Superintendent Tony Pirota said.

"Things are so tight now with the economy that a longer agreement could wind up hurting either side, so we went with two years," Pirota said. "Overall this agreement is a win-win for everyone. We had a very positive negotiating experience, with a lot of great discussion."

Teachers agreed to concessions in prescription co-pays and a change in retirement incentives, which will save the district money. By switching to a higher prescription co-pay of \$5 to \$10, the district estimates it will save \$291,870 over the two-year contract. The co-pays were \$1 to \$8 in the last contract.

Tully also changed its dental plan to a self-funded program, which provides the same benefits, but saves the district \$20,305.

The district also eliminated its retirement incentive that gave teachers an extra half-year's pay for retiring. Instead, teachers who work beyond 35 years get their salary bumped up by \$3,000. The contract calls for two other longevity bumps. The measure will save the district about \$40,000 a year.

Clerical workers settled on a two-year contract with 4 percent raises, but agreed to a three-tier prescription plan.

There are about 90 teachers in Tully, and eight clerical workers. Starting salary for Tully teachers is about \$40,000, and clerical workers start at \$7.55 an hour.

- Not a 2% tax cap
- Exclusions defined by law may provide for levy beyond 2%
- Current projection is approximately 3%
 - Still awaiting final guidance from State Education Department
- Limits revenues unless public supports levy greater than tax levy limit by 60% or more positive vote.

- Already assuming \$750,000 of reserves applied to budget
 - Less than previous two years
 - Not able to refill the reserves to the same levels
 - Less and less fund balance included in the budget each year
 - More and more reduction of buffers built into the budget

- **What is Board target for a tax levy?**
 - As of 2/3/2012 we are about \$1.3 million away from a 2% increase in the tax levy
 - Need to do a combination of increasing revenues and reducing expenditures to total that amount
 - Still working through budget numbers from the buildings and departments (i.e. Operations, Transportation, Technology, etc.)
 - Awaiting final numbers from BOCES (but we have a general idea)
 - ***Projected*** Tax Levy Limit is in the range of 3.0%
 - Still awaiting numbers from NYS for accurate calculation
